PRIVACY POLICY

BACKGROUND:

Be Special Model Agency ("we", "us", "our") understands that your privacy is important to you and that you care about how your personal data is used. We respect and value the privacy of everyone who visits this website, www.bespecialmodel.com ("Our Site") and we will only collect and use personal data in ways that are described here, and in a way that is consistent with our obligations and your rights under the law. Please read this Privacy Policy carefully and ensure that you understand it. Your acceptance of this Privacy Policy is deemed to occur upon your first use of Our Site. If you do not accept and agree with this Privacy Policy, you must stop using Our Site immediately.

How does the Website Work?

The Website offers anonymous browsers ("Visitors") the opportunity to learn more about us. Visitors who register with the Website ("Registrants") have the opportunity to submit an application to us, through the Website, to try to become a model who is represented by Be Special Model Agency ("Application"). By using the Website, you acknowledge your acceptance of this Privacy Policy and your consent to the collection, use, disclosure, management, and storage of your Personal Information by Be Special Model Agency as described herein. Be Special Model Agency reserves the right to change, at any time, the handling practices for information we collect through the Website.

We will update this Privacy Policy to reflect any changes in our data collection and handling practices and will indicate that changes to this Privacy Policy have been made by listing a new date under "Last Updated" at the end of this Privacy Policy. Such changes will take effect immediately once posted to the Website.

What Does This Policy Cover?

This Privacy Policy applies only to your use of Our Site. Our Site may contain links to other websites. Please note that we have no control over how your data is collected, stored, or used by other websites and we advise you to check the privacy policies of any such websites before providing any data to them.

What type of Personal Information does Ford Models collect and how do we use it?

Be Special Model Agency does not require you to provide us with any Personal Information to browse the Website. Be Special Model Agency does not collect Personal Information from individuals except when it is specifically and knowingly provided. For example, to submit an Application to Ford Models, Registrants must provide us with certain Personal Information, including without limitation (i) a Registrant's name, address, telephone number and email address, (ii) a detailed description of the Registrant's physical attributes, and photographs/videos of a Registrant ("Content"). All Personal Information that is collected is for a specified and legitimate purpose and is considered adequate, relevant, and limited to what is necessary for such a purpose.

Unless you provide your Personal Information to Be Special Model Agency through the Website, we will not collect any Personal Information from you. In the event you submit your Personal Information to us, we will use such Personal Information for internal purposes, for contacting you about events and media related to Ford Models' activities and we may share such Personal Information with third parties who may contact you as well with news and offers. You may opt out of such communications if they do not interest you. We may also release such Personal Information to third parties if we believe such release is necessary to comply with the law (e.g., a legal process or a statutory authorization), to apply or enforce our customer agreements, to protect our rights or property, if we reasonably believe that the physical safety of a person is threatened, or as part of a corporate reorganization, consolidation, merger, or sale of substantially all of the assets of Be Special Model Agency.

Please keep in mind that, if you are accepted as a model by Be Special Model Agency, portions of the Content contained in your Application may be made publicly viewable on the Website by us. Do not submit any Content to the Website that you are not authorized to distribute to the public or that you don't want others to see.

What other information does Ford Models collect?

We also may collect anonymous and aggregate information from you about your preferences in navigating the Website by using cookies, action tags and other methods. Cookies are small text files that identify your computer. We may use cookies to, among other things, monitor Website usage, customize Website features, identify your computer's operating system and browser, and complete transactions. An action tag is a small, graphic image on a webpage that is designed to allow the website owner or a third party to monitor who is visiting a website by collecting the IP address of the computer to which the tag is sent, the URL of the webpage that the tag comes from and the time that such webpage was viewed. Tags may be associated with cookie information. We may also use such anonymous and aggregate information for promotional purposes.

If you do not want us to track such information about you, you can set your browser to warn you before accepting cookies and refuse cookies when your browser alerts you to their presence. You can also adjust the settings in your browser to refuse all cookies.

You can be assured that Personal Information collected through the Website is maintained in a manner consistent with current industry standards. Your Personal information is protected in several ways. Your personal information resides on a secure server that only selected Be Special Model Agency, employees and contractors have access to via password. We encrypt your Personal Information and thereby prevent unauthorized parties from viewing such information when it is transmitted to us. Unfortunately, no data transmission over the internet or any wireless network can be guaranteed to be 100% secure. As a result, while we strive to protect your Personal Information, you acknowledge that: (a) there are security and privacy limitations of the Internet which are beyond our control; (b) the security, integrity, and privacy of any and all information and data exchanged through the Website cannot be guaranteed; and (c) any such information and data may be viewed or tampered with in transit by a third party.

While we take reasonable efforts to protect Personal Information that you provide to us, we cannot guarantee that such information will not be lost, disclosed or accessed by accidental circumstances or by the unauthorized acts of others.

What other information do Be Special Model Agency share?

We will not rent or sell your information to third parties without your consent, except as noted in this Privacy Policy. We may share your information as set forth above with businesses that are legally part of the same group of companies that Ford Models is part of, or that become part of that group ("Affiliates"). We also may share your information as set forth above to providers that help us provide the services to you ("Service Providers"). Our Service Providers will be given access to your information as is reasonably necessary to provide the service under reasonable confidentiality terms. We may remove parts of data that can identify you and share anonymized data with other parties. We may also combine your information with other information in a way that it is no longer associated with you and share that aggregated information.

Legal Basis for processing personal information under the General Data Protection Regulation ("GDPR")

If you are in the European Union ("EU") Be Special Model Agency will only process your personal information when it has a lawful basis to do so. This includes:

- You have g. Thes consent to do so;
- Such processing is necessary to Be Special Model Agency performance under a contract to which you are a party;
- The processing is necessary for compliance with a legal obligation to which Be Special Model Agency is subject;
- Such processing is necessary in order to protect your vital interests; or
- The processing is necessary for the performance of a task carried out in the public interest or our legitimate interests and is not overridden by your rights.

All personal information that is processed is accurate based on what you have conveyed to us and will be kept up to date as we are informed of changes.

Your rights under the GDPR

Users residing in certain countries, including the EU, are afforded certain rights regarding their personal information under the GDPR. This includes the right to:

- request a copy of their personal data;
- request that their inaccurate personal data is corrected;
- request that their personal data is deleted and destroyed under certain circumstances;
- request that we restrict the processing of your personal information;
- withdraw your consent at any time where Be Special Model Agency relies on your consent to process your personal information; and
- opt out of receiving electronic communications from us.

Does Ford Models provide links to other websites?

Be Special Model Agency may provide links to other websites or resources of possible interest to you. Because we have no control over unaffiliated websites to which we provide links, the collection and use of your Personal Information and other information by such websites shall be subject to the policies and procedures of such websites and not this Privacy Policy. Be Special Model Agency is NOT responsible for the privacy practices or the content on any of these other websites, including any sites that may indicate a special relationship or "partnership" with Be Special Model Agency. Be Special Model Agency does not disclose unique identifiers to those responsible for the linked sites. The linked sites, however, may collect personal information from you when you link to their site. To ensure protection of your privacy, always review the privacy policies of the sites you visit.

Newsletters

Be Special Model Agency may offer newsletters to share content information about this website with interested users. Be special Model Agency uses contact data from our newsletter subscriptions to send users the newsletters.
